## Days of 92 Mining Events Vendor Booth Registration Information

**PLEASE READ THOROUGHLY BEFORE CONTACTING KRISTEEN WITH QUESTIONS, I HAVE TRIED TO PROVIDE AS MUCH INFORMATION AS POSSIBLE!**

DATE: Saturday, July 4<sup>th</sup> and Sunday, July 5<sup>th</sup>, 2026 (With mandatory set up on Friday, July 3<sup>rd</sup>, 2026.)

WHERE: West half of parking lot and dirt parking lot area south of the Kentucky Belle Market parking lot.

SPACE – Crafts & Non-Food: 10' X 10' booths for **\$95.00 each**. Booth locations will be assigned in the order registration and payment is received. Actual size of booth is at least 11' x 11'.

SPACE - Food: 10' X 10' booths for **\$270.00 each**. Booth locations will be assigned in the order registration and payment is received. Actual size of booth is at least 11' x 11'. There is an additional generator fee of **\$75.00** if you will be **using the generators over night**, and an additional fee of **\$25.00** if you will be using the generators **July 2<sup>nd</sup>**.

FOOD VENDORS: Must include a sample menu with their registration form.

CHECK-IN and SET-UP: **Friday, July 3<sup>rd</sup>** is the only set-up day. All vendors who have a trailer as part of their set-up MUST be present to set up at the beginning of their designated time. Any vendor who is not ready to set up at the designated time will forfeit their space(s) and will be reassigned a spot that doesn't affect other vendors setting up. Within the paved parking lot and street, absolutely no stakes can be used. Tents, etc. MUST be secured by weights, sandbags, etc. Vendor's tent or trailer MUST FIT WITHIN SPACES PAID FOR or you may not be allowed to set up. (If your setup is more than 10' long or wide, then you will need to pay for a second spot, if is more than 20' long/wide then you will need to pay for a 3<sup>rd</sup> spot.etc.) This will be ENFORCED as we have more food vendors this year!

Food Vendors- **8am–10am**, Food Vendors with trailers must be ready to set up by 8 am. If you do not have a trailer you must set up before 10 am. Food vendors may open for business after they are set up.

Crafts & Non-Food Vendors- **12pm-5pm**.

Kristeen will be available to show vendors where their space(s) are located.

**All Vendors must be open and ready for business by 9am on July 4<sup>th</sup> and July 5<sup>th</sup>.**

Hours of operation will be 9am–5pm. Vendors may stay open longer. **You may not close before 5 pm.**

FEES: All Fees are to be submitted at the time of registration. Cancellations are to be in writing or emailed. 20% of registration fees (\$19.00 or \$54.00 per space) are non-refundable if cancellation notice is received on or before June 27, 2026. **Please notify me ASAP if you are unable to attend. That will allow me to adjust spaces so there are not empty spaces in the main area.** Registration fees are non-refundable if cancellation notice is received on or after June 28, 2026.

LICENSES: **All vendors must have a Colorado State Tax or Special Events Sales Tax License. A Tax ID number must be provided before booth assignment and/or set up of booth. NO EXCEPTIONS**

**LODGING:** For lodging and camping information, please call the Chamber at 1-800-327-2102 or [www.creede.com](http://www.creede.com)

**TAKE DOWN:** Vendors on the pavement must be packed with their area cleaned by **10:00pm on Sunday, July 5<sup>th</sup>**. Vendors in the dirt lot must be packed and their area cleaned by 10:00am on Monday, July 6<sup>th</sup>.

**OTHER:** All vendors are responsible for their display and for set up, tear down and clean-up of their booth space. You may NOT pull vehicles in to clean up until AFTER 5pm on Sunday, July 5<sup>th</sup>.

Booth spaces not cleaned up will be subject to a clean-up charge.

Recreation will provide a generator for the food Vendors. Food vendors need to provide their own extension cords. If a food vendor sets up on Wednesday evening, there will be an additional \$25 fee for the generator use, and they are responsible for keeping their generator fueled, as we will not have security there until Friday evening. A craft vendor who needs electricity must contact me before registration form is sent in to see if a hook-up to the generator will be possible. If it is possible, an added fee of \$175 will be charged.

The Days of '92 and the Creede Parks and Recreation assume no responsibility for vendor equipment, inventory, or other property.

There will be security patrolling the vendor area from 10pm–6:00am July 3<sup>rd</sup> and 4<sup>th</sup>.

The wind can blow very hard. If you have a tent, you must have very stout tie-downs but no stakes.

We will once again have the showers available at the Rec Center for vendors that would like to use them. They will be open from 6-8pm in the evening, and from 6-9pm in the morning. I will provide you with the code upon check in.

You may park your RV/camper in the lower dirt lot. You MUST have a QUIET generator if you run one. If you park at the rec center, we just ask that you park in the spaces furthest from the main entrance. Please let me know if you plan on parking overnight in the dirt lot. You will need a placard to park.

I will typically email you within 2 weeks of you sending out your registration to let you know that we have received it. It takes about 2 weeks to arrive in Creede, be picked up by the City office team, be processed, sent to the rec center, and for me to receive it and then enter it. If I have not emailed you within 3 weeks of the date you mailed it, then contact me.

**\*\*There will be NO parking allowed on Loma street (The street to the west of the vendor area) at all. The city will have barricades and fencing up. (This decision was made because emergency services had difficulty responding to an accident last year). There is also NO vendor parking in the Kentucky Belle parking lot. There will be designated vendor parking next to the dirt lot.**

Before setting up a copy of this must be signed by each vendor.  
Please initial each box to show that you have read and understood.

- 1) Each vendor will be responsible for any damage to the paved parking lot in his/ her space(s). No stakes may be used to tie down tents or tables. Other weight systems must be used that will cause no damage to the parking lot surface. If a vendor causes damage to the parking lot, they will be billed for the repair
- 2) Vendors **must take all their trash to the dumpsters located on the north and south ends of the lot, do NOT fill up the trash cans that are there for the consumers.** There will be one dumpster north of the cement barricade in front of the first food vendor, and one dumpster on the east side of 3<sup>rd</sup> street. Vendors must use these dumpsters for ALL of their trash. PLEASE do NOT use the small containers set out for the consumers.
- 3) Your area must be cleaned of your trash before you leave. Food vendors, you must clean any and all oil spills off the asphalt.
- 4) **Vendors may NOT park in the Kentucky Belle parking lot. You can pull in to unload, but you MUST move your vehicle OUT of the parking lot after you have unloaded! There is parking for Vendors only on the dirt road (Railway ave.) next to the lower vendor area.**

I understand all REQUIREMENTS for this event: Vendors are responsible for collecting and paying applicable taxes and for obtaining required licenses or permits. I understand that the City of Creede reserves the right to limit vendors of the same industry. Cleaning fee: if excess grease or waste is left in assigned vendor spot, Creede Parks and Recreation/City of Creede will charge me a \$100 cleaning fee. You are responsible for taking any and all trash to the large dumpsters provided or taking it with you. Do not leave it on site. By signing this, I agree to the terms above.

Each vendor must check out with Kristeen before you leave in order to be in good standing for the next season.

If you do not adhere to these requirements, you forfeit being able to return as a vendor in future years.
